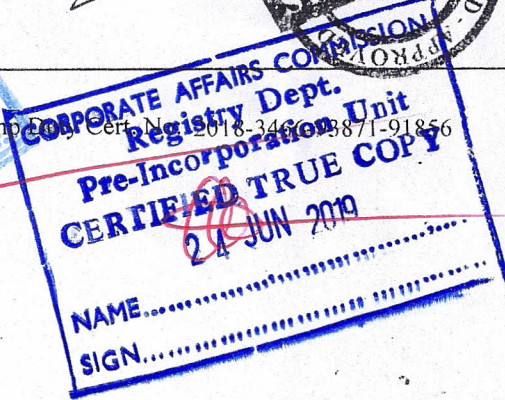
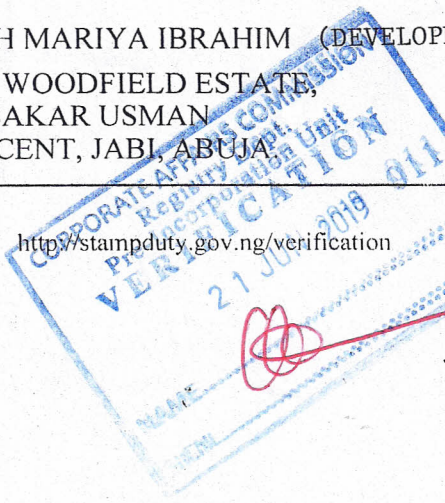
to the members of the company except as permitted by or under the companies and allied matters act.

7. **1. INTERPRETATION**

Unless the content otherwise requires, words or expressions contained in these regulations bear the same meaning as in the Act.

**2. MEMBERSHIP OF THE COMPANY**

The number of members with which the company proposes to be registered is ten, but the directors may from time to time register an increased member.

**3. MEETINGS**

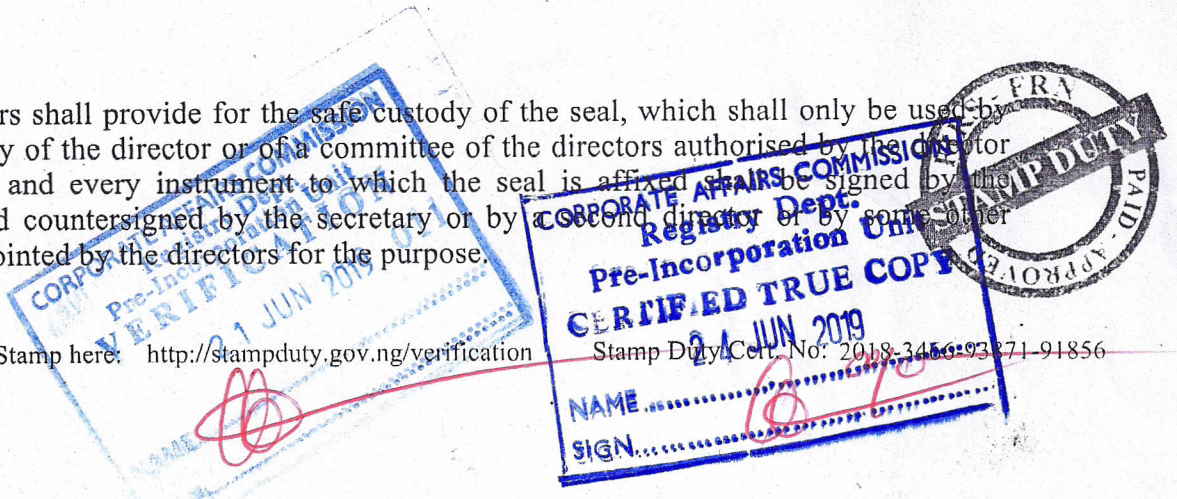

If at any meeting no director is willing to act as chairman or if no director is present within thirty minutes after the time appointed for the holding the meeting, the members present shall choose one of their number to be chairman of the meeting.

**4. THE SEAL**

The directors shall provide for the safe custody of the seal, which shall only be used by the authority of the director or of a committee of the directors authorised by the director that behalf and every instrument to which the seal is affixed shall be signed by the director and countersigned by the secretary or by a second director or by some other person appointed by the directors for the purpose.
